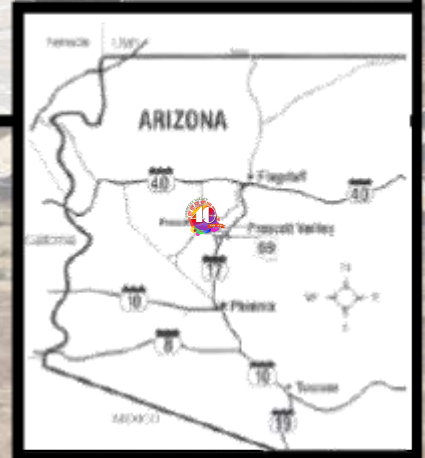
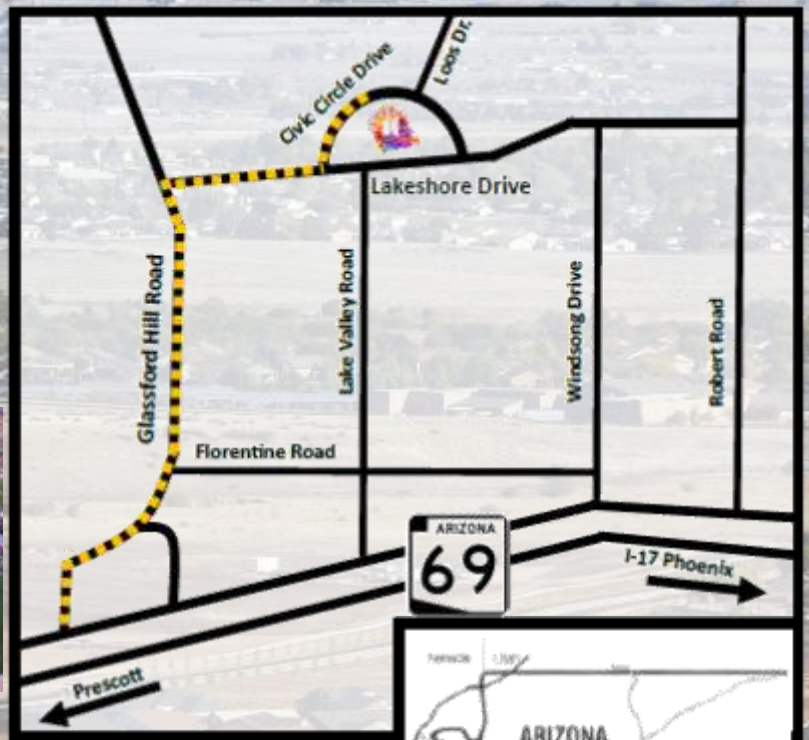


40th Anniversary Celebration

Application Deadline: August 10, 2018

SUBMISSION INFORMATION:

(Please be sure you have included all of the following.)

Applications must be postmarked by July 31, 2018 and are accepted until August 3, 2018.

We will not accept any hand delivered applications after July 31, 2018.

We require:

Completed application with: current biography (NOT HAND WRITTEN) IN MICROSOFT WORD, OR ADOBE ACROBAT IF E-MAILED; photo (8" x 10" preferred) or high resolution digital photo via email

1 PRINT READY OR HIGH RESOLUTION BAND LOGO VIA E-MAIL

1 COMPACT DISC OR HIGH RESOLUTION MP3 FILE VIA E-MAIL WITH A MINIMUM OF 4 SONGS OF ALL THE VARIOUS TYPES OR STYLES YOU PLAY that is reflective of your stage performance.

Example: If you are applying as a singer/songwriter, please do not submit a CD with you and a full band, these submissions will be placed in a different category.

Please do not use fiber mailers as they may cause your performance medium to malfunction.

1 COMPLETE AND CURRENT RIDER AND/OR STAGE PLOT WITH EXPECTED EQUIPMENT NEEDS (IF THE RIDERS OR STAGE) PLOTS ARE NOT CURRENT, THEN THE PERFORMER WILL BE IN BREACH OF CONTRACT.

Please provide video if applying for a performance artist in the Children's Area.

Set-up/Take Down

Although entertainers are invited to set up before their performance we ask that you use only 15-30 minutes before and 15-30 minutes to take down of scheduled performance time.

Weather

The Town of Prescott Valley shall not be responsible for the cancellation of the 40th Anniversary Celebration or damages incurred due to natural disaster, adverse weather, acts of God, public enemy, or any other event beyond the control of the event organizers. What to expect weather wise: Heat - extra water for the day in your booth; Cold - temperatures below 50° at night and in the mornings; Wind - gust that just show up without warning (the event does not provide sandbags or weights of any kind); Rain - make sure you are prepared for the rain to come without warning.

The 40th Anniversary Celebration

The 40th Anniversary Celebration will be extensively advertised on the web, local and regional newspapers, radio and TV.

Payment

Entertainers will be paid the day of their performance, provided that their contract/W9 forms have been completed properly and with enough time to be processed.

Entertainer Requirements

As you may guess, we have very limited spots. We are taking application for the Main Stage, Entertainment Tent, and Street (Adult and Children Entertainment). We hope to make this year's celebration the best ever, and we are looking for exceptional entertainment to do so. We are a family oriented event. With that in mind, we have guidelines we must meet for the community:

We are looking for performing groups that are and/or have:

1. "Team Players" with positive attitudes!
2. Any and all music or entertainment styles and genres.
3. Professional looking performance with professional behavior.
4. A quality act that is interactive with the audience!
5. Understanding of the logistics of a professional festival (no you will not be able to park all day at the entertainment parking lot, or drive your vehicle right up to the stage, and although we offer assistance . . . you may have to haul some gear)
6. An understanding that if your "Performing Group" is not family entertainment (profanity, nudity, racial slurs, etc.) you will not be considered.
