CALL FOR ENTRIES: All artists residing in Arizona and that are over the age of 18 can submit original art work. Eligible art work must be completed after Sept. 1, 2008. All visual and & 3-D medias (excluding Video) , are no larger than 20" X 30" and 3-D work weighting less than 35 lbs. will be accepted. Exceptions of 3-D weight can be made by contacting Sid Freeman at (928) 772-1767. Work must be gallery ready. No saw tooth hangers will be hung. This is a juried show and initial entry jury will be done from submitted photographs. Cash awards will be award by a third party judge from the hung show. No commission will be charged but each artist will be responsible for their own tax obligation.

ENTRY FORM: All entry forms must be received by **Sept. 15, 2010** and will include:

- a. \$12.00 per each piece of art work (non-refundable). Please make checks to PVAG and mail to: P.O. Box 26577, Prescott Valley, AZ 85312.
- b. 4" X 6" to 8 ½ X 11" photographs of each Piece. 3-D work must include 2 photos; one full view and one detail view. These should be labeled on the back with artist's name, title and marked at the top with a red dot or arrow.
- c. Stamped self addressed envelope (business size) for jury results and S.A.S.E (optional) for return of photographs.
- d. A complete entry form.
