
**Town Council
Board and Commission Selection Committee
Meeting Minutes
March 4, 2020**

1. CALL TO ORDER: Vice Mayor Lora Lee Nye called the meeting to order at 10:16 a.m., Room 410, 7501 E. Skoog Blvd., Fourth Floor.
2. ROLL CALL: Present: Vice Mayor Lora Lee Nye and Council Members Rick Anderson and Marty Grossman and Executive Assistant Lea Duke
