


**Town Council**  
**Board and Commission Selection Committee**  
**Meeting Minutes**  
**July 17, 2020**


1. CALL TO ORDER: Vice Mayor Lora Lee Nye called the meeting to order at 8:30 a.m., Room 406, 7501 E. Skoog Blvd., Fourth Floor.
2. ROLL CALL: Present: Vice Mayor Lora Lee Nye and Council Members Rick Anderson and Marty Grossman and Executive Assistant Lea Duke  
Applicants: Zachary Moss, Michael Greer and Michelle Ebarb
3. BOARD INTERVIEW: The Board and Commission Selection Committee Members interviewed Zachary Moss for a vacant position on the Parks and Recreation Commission. There was discussion about Mr. Moss's strengths, qualifications, time constraints, challenges and work ethic. Vice Mayor Lora Lee Nye explained to Zachary that he will be notified of the Selection Committee's decision.
4. BOARD INTERVIEW: The Board and Commission Selection Committee Members interviewed Michelle Ebarb for a vacant position on the Library Board of Trustees. DISCUSSION/POSSIBLE ACTION: Council Member Marty Grossman motioned to recommend Zachary Moss for appointment to the Parks and Recreation Commission with a term expiring June 30, 2023, Michelle Ebarb for appointment to the Library Board of Trustees to a term expiring June 30, 2022, and recommend Michael Greer be referred to Volunteer Central to seek opportunities to serve the town. Council Member Rick Anderson seconded the motion. Lora Lee Nye voted (Yea), Rick Anderson voted (Yea) and Marty Grossman voted (Yea). Motion passed.

9. ADJOURNMENT: Vice Mayor Lora Lee Nye adjourned the meeting at 9:52 a.m.
