PLANNING & ZONING COMMISSION

The following listing of agenda items represents materials discussed by the Planning and Zoning Commission during regular session on August 10, 2015 at 5:30 p.m.

Members present: Chairperson Yeater, Commissioner Renken, Vice-Chairperson Dreves, Commissioner Zurcher, Commissioner Rutherford, Commissioner Roberts and Commissioner Duskey. Staff Present: Carmen Ogden, Planner; Joe Scott, Planner; Richard Parker, Community Development Director and Kristi Jones, Administrative Specialist.

Public Hearing Items:

1. **GPA15-002.** Upon the application of Fain Signature Group, a public hearing to consider an amendment to *General Plan 2025* changing the land use designation of an approximately 9 acre parcel from Mixed Use Low Intensity Use to Residential Use. Property located south of Florentine Road and east of Main Street in the area known as the Entertainment District.

Action GPA15-002

Commissioner Renken moved to approve GPA15-002, and forward to the Town Council for approval. Commissioner Zurcher seconded the motion. Motion carried 6:0 by roll call vote with Commissioner Roberts abstaining. Commissioner Duskey voted "yes with great reservation."

2. **GPA15-003.** Upon the initiation of the Town of Prescott Valley, a public hearing to consider an amendment to Chapter 6, Circulation Element of *General Plan 2025* relative to intersection configurations in the Downtown area.

Action GPA15-003:

Commissioner Renken moved to approve GPA15-003 as submitted and forward to the Town Council for approval. Vice-Chairperson Dreves seconded the motion. Motion carried unanimously by roll call vote.

3. **ZOA15-001.** Upon the initiation of the Town of Prescott Valley, consideration of an ordinance amendment amending Articles 13-02 "Definitions," 13-06 "Use Regulations," 13-17 "Use Regulations," 13-21 "Accessory Buildings, Structures and Uses," and 13-24 "Off-Street Parking Requirements (Minimum)" in Chapter 13 "Zoning" to clarify and update the use regulations related to short-term lodging.

Action ZOA15- 001:

Commissioner Zurcher moved to approve ZOA15-001 as submitted and forward to the Town Council for approval. Commissioner Renken seconded the motion. Motion carried unanimously by roll call vote.

Action Items

1. **RP15-003.** Upon the initiation of the Town of Prescott Valley, consideration of a Reversionary Plat of a portion of Viewpoint Drive (formerly El Camino Real) for the purpose of realigning the intersection at Long Look Drive.

Action RP15-003:

Vice-Chairperson Dreves moved to approve RP15-003 as submitted, and forward to the Town Council for approval. Commissioner Zurcher seconded the motion. Motion carried unanimously by roll call vote.

2. **RP15-004.** Upon the application of Charles McKee, consideration of a Reversionary Plat to combine Lots 100 and 101, Prescott County Club Unit 6, located at 1427 N. Rustlers Roost, Dewey, AZ.

Action RP15-004:

Commissioner Roberts moved to approve RP15-004 as submitted, and forward to the Town Council for approval. Commissioner Renken seconded the motion. Motion carried unanimously by roll call vote.

3. **FDP15-009.** Upon the application of Viewpoint North I, LLC, consideration of Replat of Viewpoint North – Unit Fifteen Lots 1377, 1378, 1381 through 1386, 1398 and 1399 to add a twenty (20) foot Maintenance Easement to Lots 1377, 1378, 1381 through 1386, 1398 and 1399 and to vacate a fifteen (15) foot Type 2 Drainage Easement on Lots 1398 and 1399. Generally located south of View Crest Drive and east of Rainbow Vista.

Action FDP15-009:

Commissioner Zurcher moved to approve FDP15-009 as submitted, and forward to the Town Council for approval. Commissioner Roberts seconded the motion. Motion carried unanimously by roll call vote.

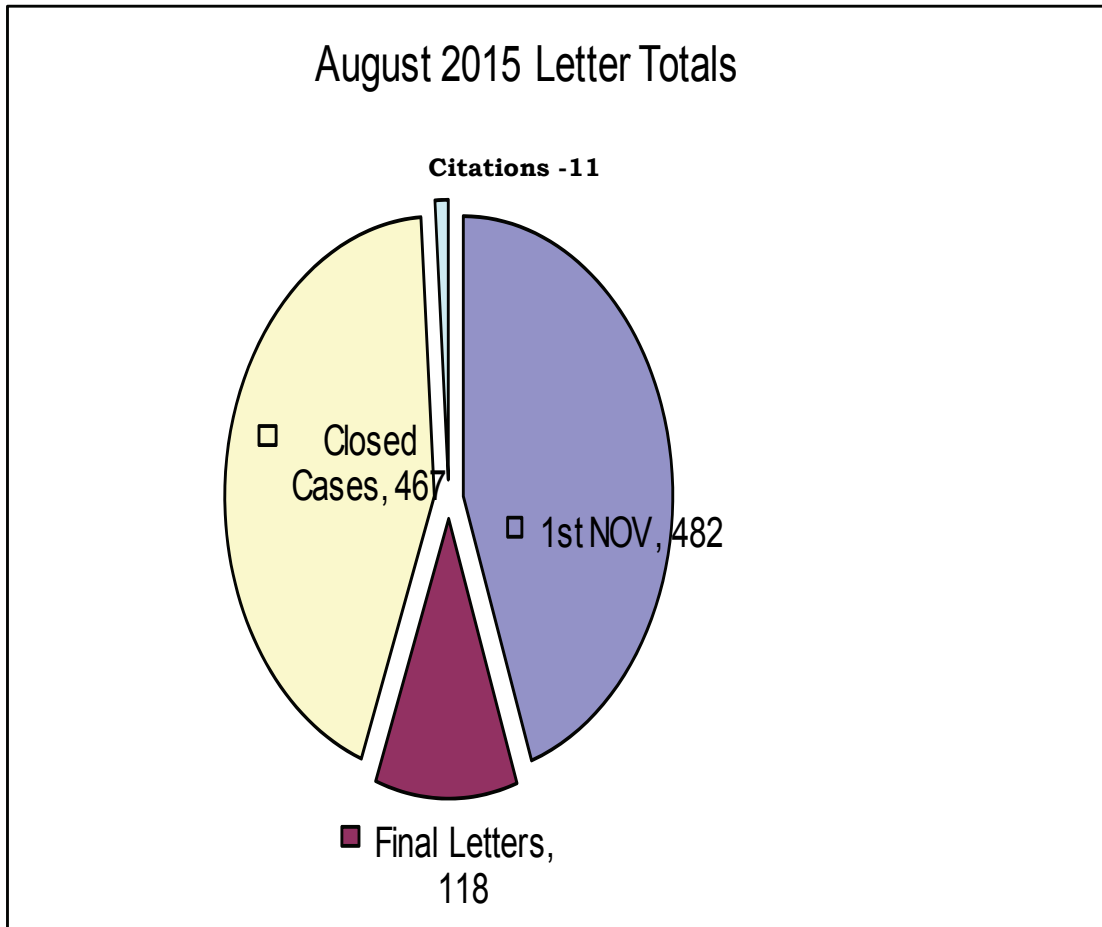
BOARD OF ADJUSTMENT

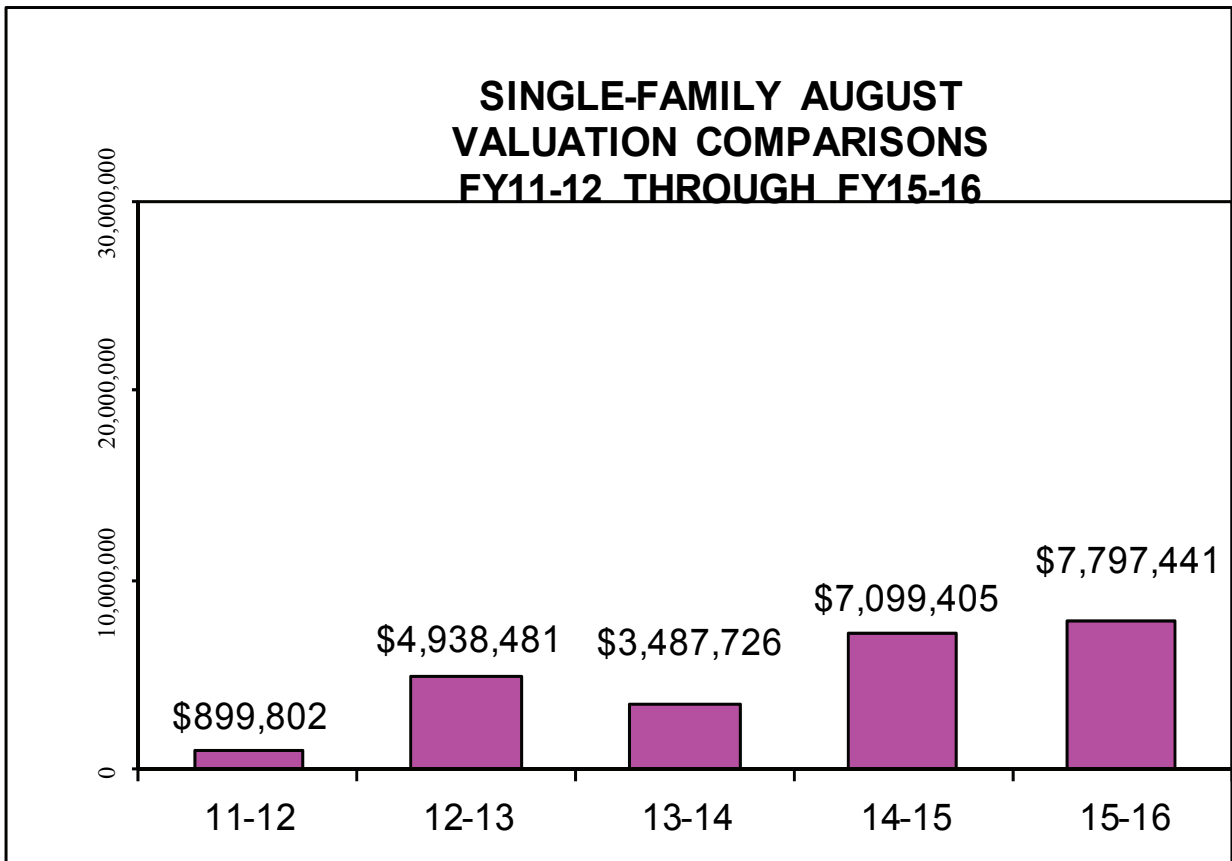
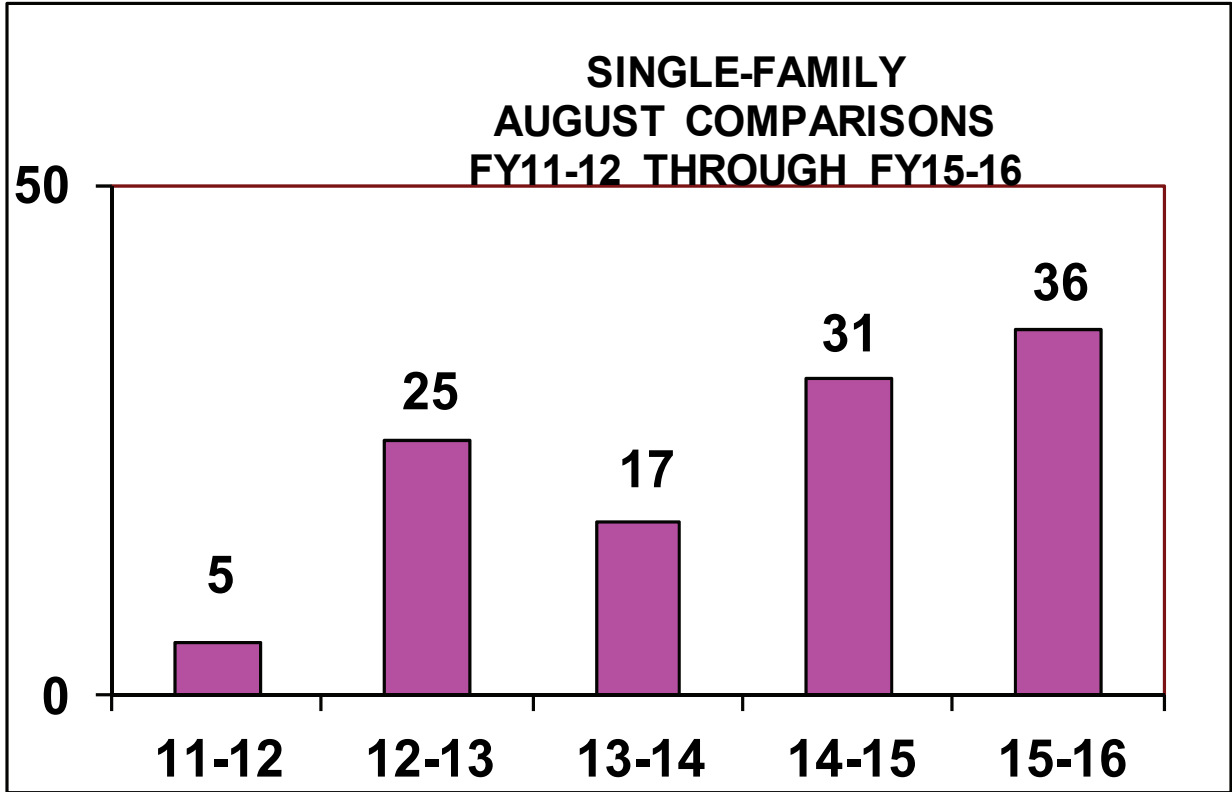
