MOTION carried with 6 ayes and 0 nays.

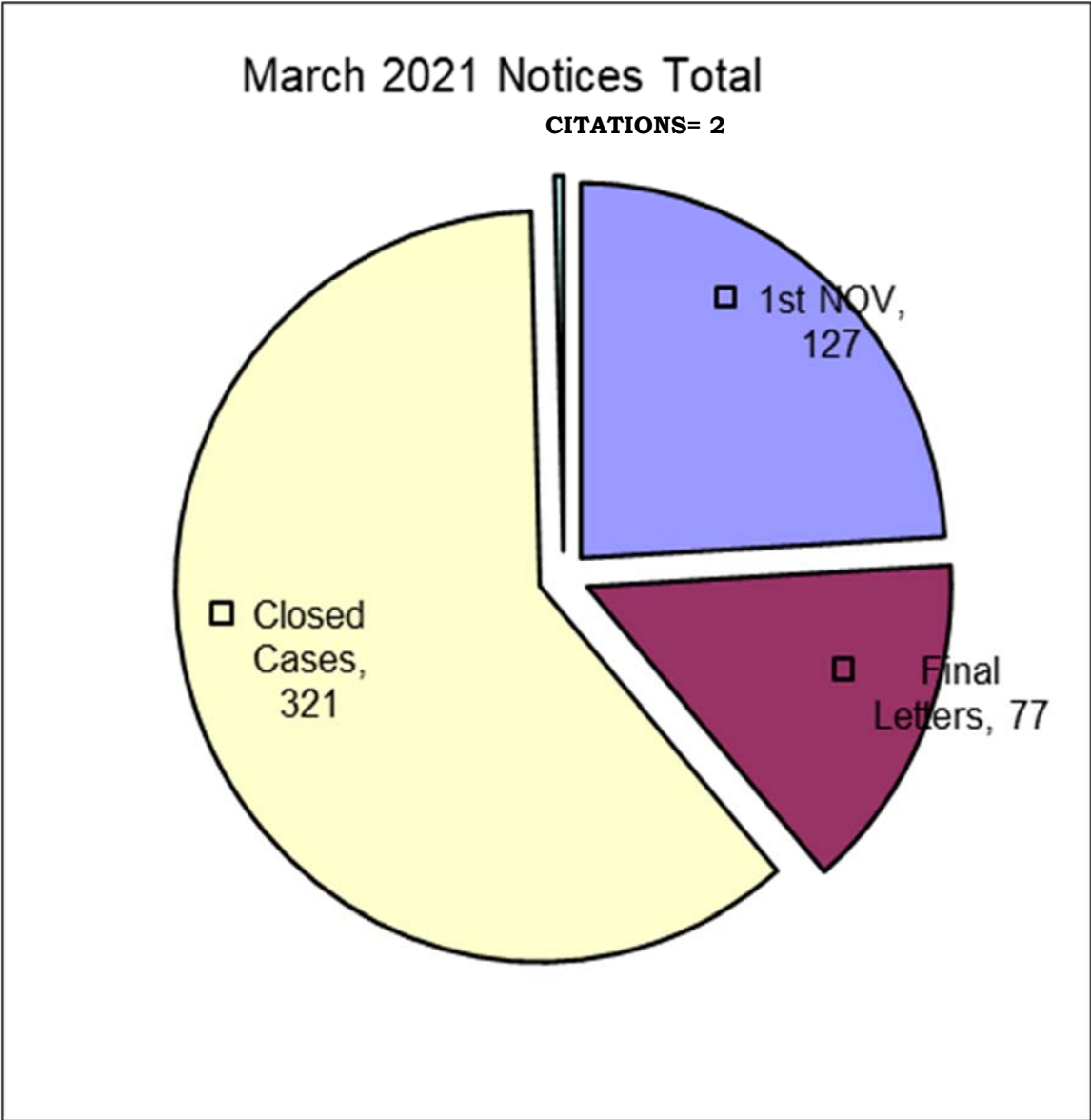

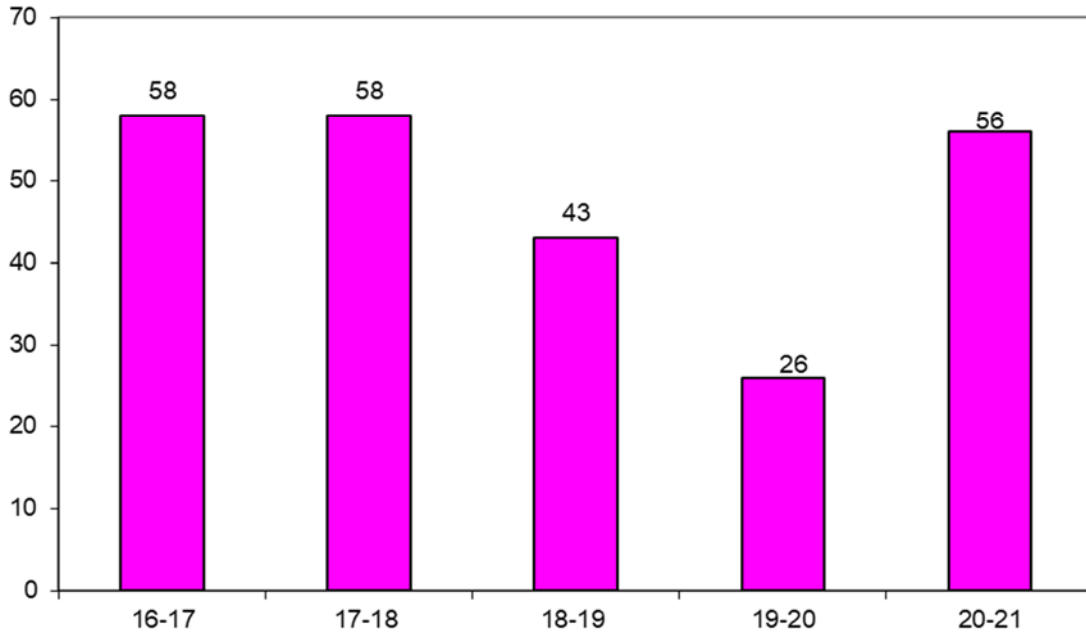

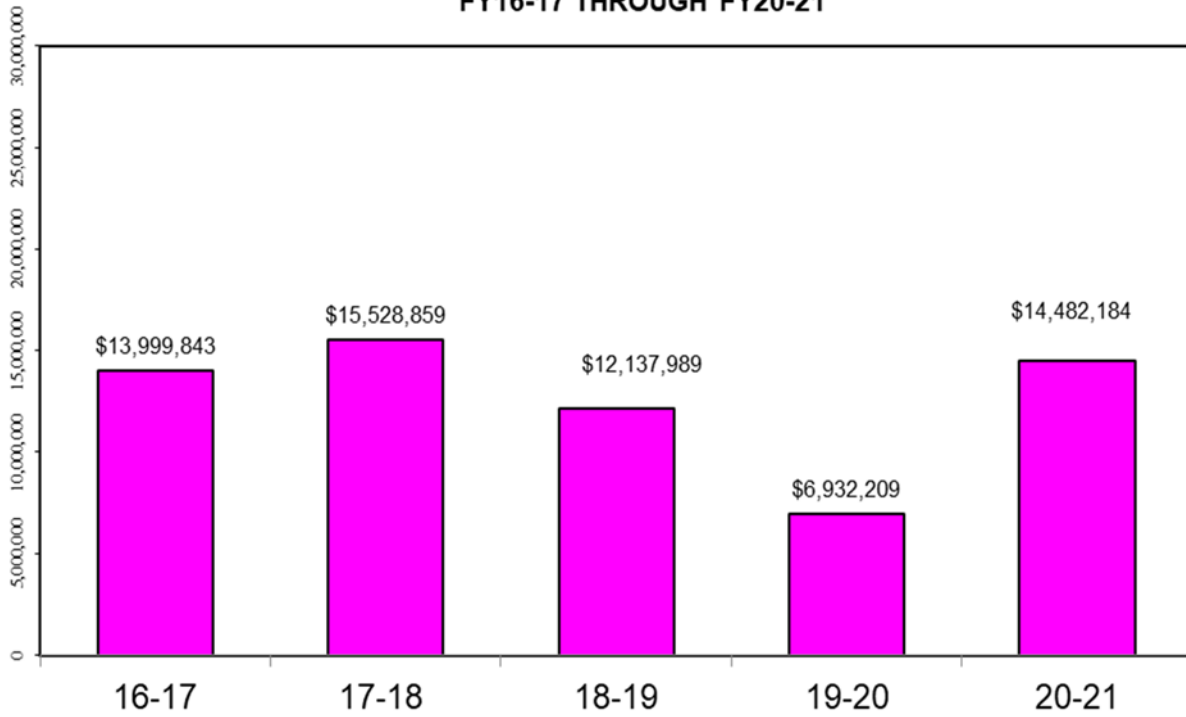

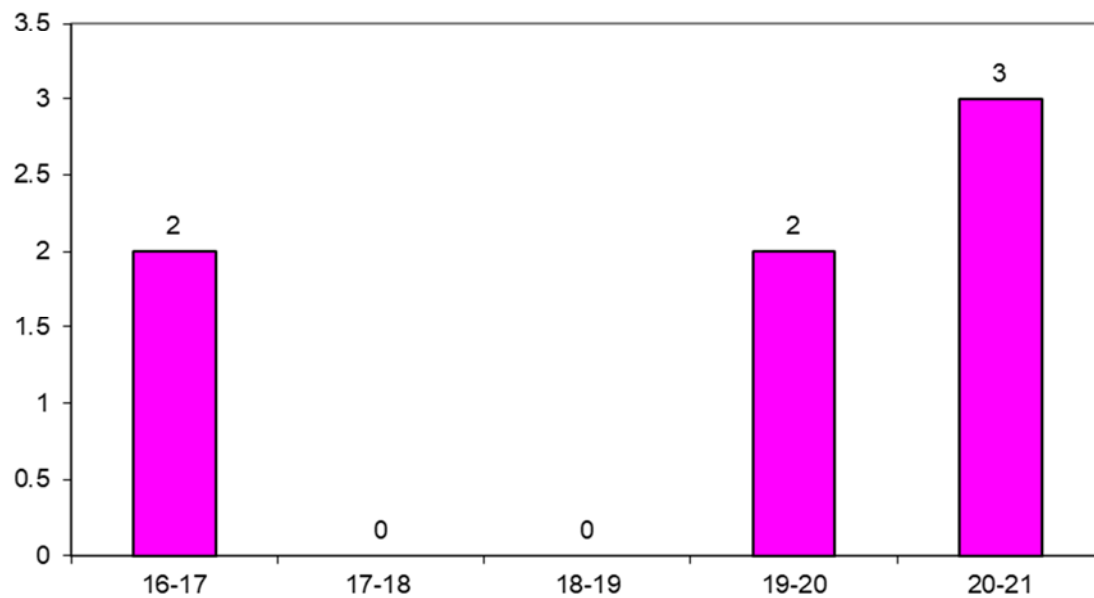


SINGLE-FAMILY MARCH VALUATION COMPARISONS FY16-17 THROUGH FY20-21
