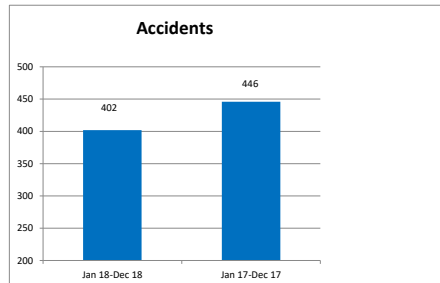
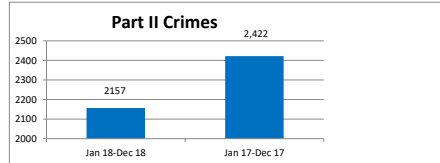
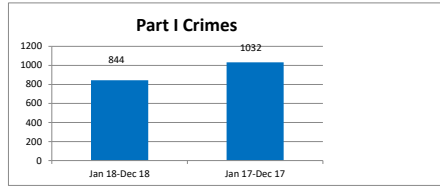

Part I Crimes

Criminal Homicide – Murder and Non Negligent Manslaughter

Definition: The willful killing of one human being by another.

Rape

Definition: The carnal knowledge of a female forcibly and against her will.

Robbery

Definition: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

Aggravated Assault

Definition: An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

Burglary – Breaking or Entering

Definition: The unlawful entry of a structure to commit a felony or a theft.

Larceny – Theft

Definition: The unlawful taking, carrying, leading or riding away of property from the possession or constructive possession of another.

Motor Vehicle Theft

Definition: The theft of attempted theft of a motor vehicle.

Arson

Definition: Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

Part II Crimes

Animal Control

Definition: Reports involving animal (primarily dog) issues, i.e. Animal Cruelty, Animal Bites, Stray Dogs, Dangerous Animals, Public Nuisance Calls Relating to Animals

Domestic Violence

Definition: Violent or aggressive behavior within the home which includes victims such as: Spouses, Dating/Intimate partners, Family members, Children, Cohabitants

Assaults

Definition: An unlawful attack by one person upon another where the victim is injured or placed in reasonable apprehension of injury. Does not involve a weapon or serious injury

Vandalism/Criminal Damage

Definition: To willfully or maliciously destroy, injure, disfigure, or deface any public or private property

Miscellaneous

Response time

Definition: The average length of time in minutes and seconds for the first unit to arrive to the scene of priority two and three calls. (high priority)

Overdose

Definition: Overdose Calls is a total and includes both Deaths and Narcan Saves.
